

Cookie statement for MotoShare

At www.motoshare.eu, a site of MotorConnect B.V., we use cookies. A cookie is a simple small file sent with pages from this website and stored by your browser on your computer's hard drive. The information stored therein can be sent back to our servers during your next visit.

In this cookie statement, we explain which cookies are set and for what purposes.

Remember settings

We use cookies to record your settings and preferences so that we do not have to keep asking for them. These are the following settings and preferences:

- an option to stay logged in (remember_web_x)
- recognising registered users (aravel_session)
- a security cookie to prevent unauthorised actions under your name (**XSRF-TOKEN**)
- remember which cookies you have given permission for (cookiesPolicyAcceptedAt)

You can block these cookies via your browser, but you will have to re-enter these preferences each time.

Functioning of the site

We use cookies to make our site work properly. These functional cookies are used only for this purpose. With them, we do the following:

- your name, e-mail address etc. so that you do not have to fill them in every time

You can block these cookies via your browser, but this may adversely affect the functioning of our website.

Social media buttons

Our website includes buttons to promote and share web pages on social networks, namely Facebook, Twitter, and these buttons place cookies

These buttons work through snippets of code that come from these social networks themselves. We have no influence on them. Please read the privacy statements of these networks (which may change regularly) to read what they do with the (personal) data they obtain via these cookies.



The information collected by these networks is transferred to the United States and stored on servers there. The companies behind these networks claim to adhere to Safe Harbor principles and are members of the US Department of Commerce's Safe Harbor programme. This implies an adequate level of protection for the processing of any personal data.

Tracking and profiles

We use so-called tracking cookies to build up a profile about you. The profile built up about you is not linked to your name, address, e-mail address and the like as known to us, but only serves to tailor advertisements to your profile so that they are as relevant to you as possible.

Right to access and correct or delete your data

You have the right to request access to and correction or deletion of your data. Please see our contact page for this. To prevent abuse, we may ask you to provide adequate identification when doing so. When it comes to access to personal data linked to a cookie, you must send a copy of the cookie in question. You can find this in the settings of your browser.

You can usually delete cookies via your browser's settings. More information on enabling, disabling and deleting cookies can be found in the instructions and/or using your browser's Help function.
